Moderator: Delegate is standing, and any delegation wishing to ask a question after the delegate seconding the motion, please raise your placard at the end of the question.

Moderator: Delegates the floor is open, are there any motions on it? [notes forum].

Moderator: Yes, delegate from France.

Delegate: Motion to vote on the possible resolution sheet.

Moderator: It is in order delegate, delegate seconding the motion?

Delegate: [Delegate raises hand] **Moderator:** Yes, delegate of Russia.

Moderator: Delegate of Russia seconds the motion. Votes in favor...[vote], against...[vote], abstentions...[vote], the motion clearly passes/fails.
